1. Block having car parking in the basement, Cafeteria at ground floor and Library at first floor with the provision in the foundations for construction of two more floors in future at FAST-NU Campus, at H-11/4, Islamabad. The covered area of basement, ground and first floor will be approximately 56,000 sft.
2. Block for Faculty parking in 2 basements and Cafeteria at ground floor with the provision in the foundations for construction of three floors in future at FAST-NU, Lahore Campus. The covered area of 2 basements and ground is approximately 37,200 sft.

Following Consultancy Services are required: -

Applications are invited under PPRA Rules from well reputed Architectural Firms with at least 15 years' experience and registered with Pakistan Council of Architects and Town Planners (PCATP). Principals of firms must be registered with the PCATP and also with CDA and LDA as Licensed Architects. Pre-qualified architectural firms will be required to submit names and qualifications of their proposed engineering consultants (or in-house specialists) for prior approval.

2. Registration certificate with PCATP up to December 31, 2017.
3. Registration with Registrar of Firms/SECP.
4. Registration with FBR (must be included in the active tax payer list of FBR).
5. List of Professional staff with CVs indicating their relevant project experience.
6. List of similar works/projects each of at least 50,000 sft covered area completed by the firm within past 15 years with their total cost and works in hand indicating cost of each work and cost of consultancy received against the assignment along with date of start and completion or expected date of completion supported with performance certificate(s) from the Employer(s).
7. Financial position of the firm supported with audited statements of accounts of the firm for the last three (3) years.
8. Affidavit on stamp paper of Rs.100/- confirming that the firm or its any
9. Director/Partner/Employee has never been involved in any corruption nor blacklisted and its contract agreement has never been terminated due to poor performance by any Govt./Semi Govt. department/Institute.
10. Any other relevant information supporting the application.
