#### EARNEST MONEY

**1.1.** Submission of tender will be accompanied by earnest money equal to 2% of the amount of tender ONLY IN THE FORM OF PAY ORDER in the name of BCCI-FAST N.T.N # 0453657-6.

#### 2. <u>TENDER OPENING DATE AND VENUE</u>

2.1. The tender is to be submitted at 12:00 pm at the procurement office. The Procurement Committee FAST-NUCES Karachi in the presence of all the tenderers will open tenders at 02:00 pm on May 28, 2024, respectively. This activity will take place in the CS Conference Room of Academic Block 1, FAST-NUCES Karachi Campus.

#### 3. <u>PRICE/RATE</u>

- **3.1.** The tenderers shall indicate the unit price of the goods/services they propose to supply under the Contract. Price mentioned in the bid must be stated as shall be in Pak Rupees inclusive of all prevailing taxes/ warranty/GST etc.
- **3.2.** Incase bidder fails to mention prevailing taxes/GST amount separately; their quoted costs shall be treated as Price inclusive of prevailing taxes/GST. Prices quoted by the Bidder must be fixed and applicable during the Bidder's performance of the contract

and not subject to variation on any account. A bid submitted with variable price will be treated as non-responsive and will be rejected, immediately.

#### 4. VALIDITY OF THE PRICE

**4.1.** Bids should remain valid for 45 days from the date of submission.

#### 5. MODE OF PAYMENT

- **5.1.** Payment shall be made to the supplier against submission of the delivery documents i.e. Delivery Challan, Sales Tax Invoice. Bill of Entry & Proof of Payment of Duties and Taxes at the time of delivery. After completion of the respective work, the payment may be released after 15 days, accordingly.
- **5.2.** FAST-NUCES shall release Cheese/Pay Order/Demand Draft after 15 days of delivery with adequate documentation subject to satisfactory performance report submitted by the designated FAST-NUCES staff members.
- **5.3.** Payment shall be made according to actual quantities ordered by the Procuring Committee.

#### 6. LOCAL SUPPORT TERMS & CONDITIONS

- **6.1.** Once after placement of the order the vendor has to work in coordination with the campus management to avoid disturbance of any academic activity in the campus.
- **6.2.** The university may cancel the order if the continued work is not satisfactory or as per requirements.
- **6.3.** Any addition or reduction in the order or scope of work by the vendor after placement of order must be communicate to the responsible person.
- **6.4.** FAST-NUCES reserves the right to accept any tender, in whole or in part, or to negotiate further with one or more tenderers. The tenderer selected will be chosen based on value for money. This means premium quality, delivery time and after sales service will be the deciding parameters.
- **6.5.** No amendments to the Tender will be permitted after submission unless requested by FAST-NUCES. Prices and rates quoted within the Tender should be on a fixed basis for the contract period. They should remain fixed for ninety days from the tender close date.
- **6.6.** Unsuccessful bidders will be notified after contract award.
- **6.7.** Any material of a confidential nature submitted by a Tenderer should be clearly marked. All material provided by the Company must be regarded as confidential.
- **6.8.** All correspondence must be in English.

#### 7. <u>CHANGES TO THIS CONTRACT:</u>

- 7.1. No modification of this Contract will be effective unless it is in writing and signed by authorized representatives of both the FAST-NUCES and the vendor.
- 7.2. All notices will be in writing and will be given by personal delivery, certified or registered mail addressed as follows:

#### 8. PENALTY CLAUSE

**8.1.** FAST-NUCES shall impose penalties upon breach of terms & conditions and delayed remedial maintenance as per the following criteria.

Delay in delivery / installation / Order	Per day a deduction of 2% will be made in case of unmatched timelines and compromised quality of products or service or both.

#### 9. ESCALATION:

- **9.1.** If FAST-NUCES is not satisfied with the quality & level of services provided by the Supplier, the matter will be escalated in the following manner.
- **9.2.** FAST-NUCES will send a memo to the Supplier's head office with documentary evidence for poor quality of service and /or non-compliance of THIS CONTRACT.
- **9.3.** The Supplier is bound to give a written reply of this memo within seven days from the date of the memo.
- **9.4.** If FAST-NUCES is not satisfied with the reply, then a show-cause notice would be issued to the Supplier for terminating THIS CONTRACT.
- **9.5.** The Supplier is again bound to give a written reply of the Show Cause Notice within seven days from the date of show-cause notice released.
- **9.6.** After receiving the show cause notice a meeting between FAST-NUCES and Suppliers representatives may be arranged to renegotiate and address the problems.
- **9.7.** If both FAST-NUCES and the supplier ceases to reconcile then FAST-NUCES reserves the right to forfeit the Supplier's bank guarantee.
- **9.8.** As a result of this termination of Contract, FAST-NUCES also reserves the right to reassign the assignment to another Supplier of their own choice.

#### 10. ASSURANCE

- **10.1.** The Supplier will facilitate in claiming warranty/replacement of the supplied items. The vendor will be providing onsite support for any part replacement if required.
- **10.2.** The warranty period and terms & conditions of the warranty needs to be communicated in writing.
- **10.3.** Each page of the tender/bid document needs to be signed and stamped; otherwise, it will not be considered or accepted.
- **10.4.** Incomplete forms will not be acceptable.
- **10.5.** In case of any dispute, the decision of the NUCES, FAST Procurement Team will be final and binding on you.
